# **Grand Master's Edict #4 and Phase I Guidelines**


To: All members of all subordinate Masonic Lodges in Nebraska

Acting under my authority as Grand Master of Masons in Nebraska, I hereby decree that Phase I of the resumption of lodge functions and activities will begin in Nebraska effective July 1, 2020. All Nebraska lodges will implement and comply with the below Phase I Guidelines and Directives. This Edict will remain in effect until further notice.

Additionally, supplemental information is provided for increased Coronavirus-19 (COVID-19) Pandemic background and awareness.

This Edict will be reviewed regularly. If the state of emergency is lifted, or restrictions of State and/or Federal authorities substantially change, this Edict will be updated as required. imposed for the decision. Individual attendance is voluntary for lodge meetings and activities, and decisions to attend lodge are

Phase I: Nebraska Lodges Guidance, Directives, & Supplemental Information

Effective July 1, 2020

The following guidance, directives, and supplemental information have been developed as Phase I for Nebraska lodges to open facilities during the Coronavirus Pandemic. Guidance and Directives will be updated when deemed appropriate after major restriction changes are announced.

As more is learned about this new virus, be aware that conditions, restrictions, and recommendations can change rapidly. Prior to reopening a lodge, the leadership should familiarize itself with national, state, and local restrictions. Although the guidance, direction, and supplemental information being provided covers a wide range of topics, it is impossible to address every situation lodges will face.

When there is an absence of direction for unique circumstances, it is recommended that lodges refer to local restrictions, plan accordingly, and let common sense prevail.

Guidance:

Community spread of SARS-CoV-2 (COVID-19) is occurring which poses a risk to the health and welfare of all. Therefore, members voluntarily assume all risks related to exposure to COVID-19 by attending Blue Lodge meetings/activities.

If a lodge feels uncomfortable about having a meeting or activity, then do not have one. No penalty will be imposed for the decision.

Individual attendance is voluntary for lodge meetings and activities, and decisions to attend lodge are personal. Officers are reminded to inform the Worshipful Master of their planned absence beforehand.

If a brother has symptoms of COVID-19, or has family members with COVID-19, he should remain at home.

Perform a risk assessment of the lodge building. Pay specific attention to areas of high traffic, frequently touched surfaces, and meeting rooms where efforts are needed to maximize sanitation and allow appropriate social distancing.

This Guidance and subsequent Direction are the minimum. Worshipful Masters are allowed to establish stricter restrictions if they wish.

Directives: Lodge Preparation:

Develop a plan for cleaning and disinfection. Note, if the space is vacant for 7 days or longer, routine cleaning methods will suffice in most situations.

Officers will familiarize themselves and comply with local and state restrictions regarding size of gatherings prior to notifying members of meetings.

Have hand sanitizer available at the entrance of the lodge. Verify soap and water is available in all restrooms and wash areas.

Lodge Meetings:

Meetings will be opened in the Entered Apprentice Degree.

Brethren are to wear masks in the lodge building. Once the business meeting has begun, and there is a minimum of 6 feet between attendees, the Worshipful Master will announce if masks will be worn or removed. If a brother chooses to keep his mask on, he may to do so.

Upon arrival, brethren are to wash their hands with soap and water or use hand sanitizer.

Avoid shaking hands.

The general use of gloves is optional. If gloves are worn they should not be cloth.

Pre- and/or post-meeting meals, snacks, refreshments, and social

time are discouraged and left to the discretion of the Worshipful Master.

Maintain social distancing before, during, and after each meeting.

Email all communications, minutes, agendas, and reports to brethren prior to the meeting. Post a copy outside of the lodge room. Do not provide individual copies for brethren.

Balloting should be done with paper ballots. The appointed tellers should either wear disposable gloves or use hand sanitizer while distributing ballots and after counting ballots.

The Secretary will maintain an accurate record of attendees for potential contact tracking.

Lodge Activities:

Investigation committees are authorized provided the committee members and petitioner are comfortable with the meeting.

Mentoring and proficiency for individuals and round tables are authorized. If social distancing cannot be maintained, masks are strongly encouraged.

Lodge social functions and fundraising activities are authorized. If food is served as part of a social function or fundraiser, conduct the event using the same restrictions as restaurants. Comply with local and state restrictions and at a minimum masks and gloves are to be worn during all food preparation, ordering, packaging, and delivery.

Supplemental Information: How is a risk assessment performed?

Consider how many times a week the lodge building is used by all organizations including regular meetings, special meetings, youth groups, and community events.

Assess the layout of the spaces in the building to determine where high traffic areas are located with surfaces that will be frequently touched. These surfaces may include:

Lodge room furniture, tables, doorknobs, light switches, countertops, handles, desks, bathroom fixtures.

Determine if current seating arrangements are appropriate or if they need be reorganized to maximize social distancing (6 feet apart). If soft or porous materials are present, see if they can be removed or how to correctly clean them. Approved cleaning products can be found at https://www.epa.gov/pesticide-registration/list-n-disinfectants-use-against-sars-cov-2. Take stock of current cleaning supplies and verify they are effective against SARS-CoV-2.

If the building is used frequently during a 7 day period, follow the provided flow chart and sanitation guidelines outlined by the CDC.

What are the recommended sanitation guidelines?

Most recommended sanitation is based on regular routine cleaning with attention paid to frequently touched surfaces. The guidelines are split into two types of cleaning: routine and disinfection.

Routine cleaning involves using soap and water to clean appropriate surfaces. If an indoor space is vacant for 7 days or longer, then this method is recommended. This method also includes regular laundering and/or vacuuming of soft materials and clothing.

Disinfection of surfaces will kill germs and is intended for hightouch surfaces and items used frequently. There are currently 3 methods of disinfection:

Use of an EPA-registered disinfectant.

Diluted bleach solution of 1/3 cup bleach per gallon of water or 4 teaspoons per quart of water. This solution must be left on the surface for 1 minute and the solution will be effective for up to 24 hours. Do not mix bleach with ammonia or any other cleaning solution.

Alcohol solutions with at least 70% alcohol

Disposable gloves should be used during all cleaning as well as any other personal protective equipment recommended by the manufacturer. Hand washing is recommended after any cleaning and after removing gloves.

Why are gloves optional during meetings?

Gloves are an excellent way to reduce viral transmission when properly used, which many times is not the case. Proper hand washing practices are equally effective as gloves for the majority of the population. Disposable nitrile gloves should be used if the need arises, and attention should be paid to what the wearer touches while wearing them to reduce unintended cross-contamination. Gloves can be cleaned with hand sanitizer. Proper glove removal practices should be used to avoid inadvertent hand contamination, and proper hand washing must occur after removing

What steps should be taken if a brother is diagnosed with COVID-19 after a meeting?

Any brother who attends a meeting and begins displaying symptoms of COVID-19 within 48 hours should seek medical advice and alert the Worshipful Master and Secretary. The Secretary will alert those brethren who attended the meeting of their exposure potential. If a COVID-19 test is administered, the brother is asked to inform the Worshipful Master and Secretary of the result, and they will update those brethren affected. The identity of the symptomatic brother will be considered confidential information.





One of the things that has occupied my time during this trying time is working as a Mentor for the Lancaster County **Veterans Treatment** Court. This is a coalition of the Veterans Administration, Lancaster County District experiences. The Court, County Prosecutor, Public Defender, County Probation Office, Lincoln Police Dept. and former Combat Veterans as Mentors. The Veterans that are admitted to the 18 to 24-month program are men and women from all branches of military service who have available resources so committed certain felonies. After being admitted into the program, they must post a bond, plead guilty, undergo random drug and alcohol screenings, undergo counseling and treatment by the VA or other approved sources. They must attend a weekly court hearing and report to the judge their weekly activities. They also must attend and successfully complete "life lessons" such as budgeting finances, spousal abuse training, community service and such. Depending on their disability level, they must not an adversarial be gainfully employed, attend college or

vocational training, or do

voluntary work in the community. The program is divided into five levels with certain goals to be completed before advancement. When the program is successfully completed, upon graduation, the bond is returned, their felony is expunged from the record and they are given a new lease on life. As for myself, I recently have had my bank account number stolen. I had to close that account You don't realize how many places your numbers go and how hard sometimes it is to get them changed. Keep track of all of your finances and where they go.

I thought that as many of the point to catch any us are either working from home or just staying home, maybe some education on ritual work might be in order. Now would be a good time to learn a new part of a degree!

RITUAL LEARNING The first step of learning any ritual is to know what other than in the book), you're saying! This should be obvious, but is the corrections as soon often overlooked, because brethren are afraid to admit that they don't already know the afraid to admit your own limits -- I've never met anyone who gets every single word right every time. Start out by listening to someone say the speech, preferably several times. (You should be doing this the entire previous year, listening to your predecessor.) Listen and open a new account. carefully, and make sure you understand what's being said; ask questions if you don't. (After lodge, of course.) Next, go through your cipher carefully, and see how much you can read. Mark words that you can't figure out, or that you're unsure of -- this is

mistakes you may be making. Then call or get together with a Ritualist or a reliable Past Master, and talk through it, reading out of the book slowly. Have him correct any mistakes and fill in the words you don't know. Take notes (preferably somewhere because you will forget as you're on your own

Small-Scale Memorization This is never anyone's favorite part; anyone can do it, but no-one finds it simple. It's considerably easier if you do it right, though. Start out by reading the speech over and over. Don't move on to the next step until you can read it from the cipher quickly, without breaks or hesitation. Read it out loud, when you get the chance. This step is particularly important and skipped more often than any other. Don't skip it -- this is how you get your brain and mouth trained to the words. It may sound silly, but it really matters -- the mental pathways used to talk are distinct from

those used to read. Now, start trying to learn sentences. Just sentences. Read the first or two, or by thinking, word or two of the sentence, then try to fill in the remainder from memory. Don't fret if you can't do it immediately; it 5 or 10 times through before you're getting most of the sentences. You'll find some that are hard -- hammer those ones over and over (but don't totally neglect the rest while you do so). Again, get to the point where you're doing reasonably well on this, before going on to the next step.

Large-Scale Memorization Once you've got most of the sentences, try to move on to paragraphs. Again, some will be easy and some hard. Try to understand exactly why this sentence follows that and you'll never forget one -- in most cases, the ritual does make sense. An individual paragraph is almost always trying to express a single coherent thought, in pieces; figure out what that thought is, and why all the pieces are necessary. Keep at this

until you're able to get most paragraphs by glancing at the first word "Okay, this is the description of truth," or something like that. Finally, start putting it all together. This is where will probably take at least the structural analysis in Step 2 gets important. You visualized the speech and figured out how it hooks together; use that visualization to connect the paragraphs. Make sure you have some clue why each paragraph follows the one before. In almost every case, the next paragraph is either a) continuing this thought, or b) moving on to a related thought. In both cases, you can make memorization much easier by understanding why it flows like that. Convince yourself that this paragraph obviously has to follow that one, the order.


